

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.marinecorpslogistics.org> and Association of Marine Corps Logisticians and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Association of Marine Corps Logisticians include <https://www.marinecorpslogistics.org> and AMCL. The AMCL website is a Professional Association site. By using the AMCL website, you consent to the data practices described in this statement.

## Collection of your Personal Information

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through AMCL's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site.
